WHAT ARE VOTING RIGHTS?

A membership with the Morawa CRC entitles the holder with one member voting right. For example, an individual membership will have one voting right, a family has one voting right and a business or other entity has one voting right, which is automatically granted to the primary contact that is specified on your membership application form. The member voting right allows that holder to vote at General Meetings and vote for (or stand as) a Committee Member. This means, that being a Member of the Morawa CRC, you can be involved in CRC in more ways than simply being a customer!
